BACKGROUND: Zilpha [—?—], (ca.1775-80—24 June 1857), had at least three relationships:

- 1. John Price (son of Cader), who she married ca. 1798. In **1800** and **1802** she bore two children who used the Price surname. John sued for divorce in 1799; the case was continued and then cancelled. However, the couple did not stay married and Zilpha was treated as a sole feme on the 1805 land lottery (registration 1803–1804).
- 2. John Cooksey (son of William), with whom she took out a license in 1809 but no subsequent marriage is on file. Meanwhile, about **1806** and **1808**, she bore two sons who used the surname Cooksey. John is last on record in March 1818.
- 3. William Cooksey, R.W. (by whom she apparently bore James William in November 1819 and Elizabeth in 1821)

Zilpha is also likely to be the mother of Nancy [—?—] Parks, born 12 April **1804**, allegedly in Savannah. Nancy, for whom no maiden name on record, is usually credited to William Cooksey. However, all evidence for William places the birth of his known children between 1785 and 1795. There is no evidence of children born after 1795 and all records on William establish his residency in Tattnall at the time of Nancy's alleged birth in Savannah. In 1803, Zilpha registered for the 1805 Land Lottery, as a resident of Tattnall; but her whereabouts in 1804–1809 are unknown.

HYPOTHESIS:

Zilpha was the daughter of Rev. John and Judith Watts who lived in Montgomery, Tattnall, and Laurens Counties concurrently with William Cooksey and subsequently moved to Covington County, Mississippi, concurrently with William and Zilpha. Considerable evidence supporting this hypothesis is detailed in my earlier reports.



COMMENT:

Note that both of the Lotts used the law firm of Skine, Flournoy, and Berrien -- as did Zilpha when John Price sued her for divorce. Indeed, in all the litigations for whom an attorney was named, the Lotts and Watts consistently used Flournoy and/or Berrien. This pair were clearly the "family attorneys."

There are, apparently, seven attorneys doing business in three legal firms in Montgomery County at this time:

- Henry G. Caldwell (used by John Price to sue Zilpha for divorce)
- Skrine, Berrien, and Flournoy¹ (used by the Watts, Lott, Davis cluster--including Zilpha)
- Jones, Walker, and Hammel

COMMENTS:

Thomas Watts was the eldest son of Rev. John Watts and husband of Elizabeth Lott. If my working hypothesis is correct, he was Zilpha's brother. He, too, moved to Covington County, Mississippi, where the 1820 census enumerates him one dwelling away from William and Zilpha.

The above Watts-Davis-Flournoy document links four other pieces of evidence:

Jan 1798	Abner Davis bought land; witness was Cader Price, father of John
Mar 1799	John Price sues Zilpha [Watts?] for divorce; her attorney is Flournoy.
Oct 1799	John Price & father Cader exchange lands, using Abner Davis, J.P.

¹ Skrine was not an active attorney at this time because he was elected "Judge of the Middle District." The active lawyers in the firm were only Berrien and Flournoy, the two used by the Watts and Zilpha. See Sabina J. Murray, abstractor, *Tattnall County, Georgia, Loose Papers, 1801-1845*, vol. 1 (Homerville, Ga.: Huxford Genealogical Society, 2005), 17, for abstract of 10 November 1805 petition by John Ragan.

Abner Davis's land grant adjoined land of John Watts, Zilpha's proposed father.²
Oct 1803 Thomas Watts, son of John, goes to court on behalf of Abner Davis.

COMMENT: This Jno. Watts [Jr.] is not included in most reconstructions of the family of Rev. John Watts. I suspect he should be.
Many online "trees" credit John and Judith Watts with a son John Jr., although most place him toward the end of their many children. If this is their son, the fact that he is an adult by 1802 would place his birth before 1781.

Sands Stanley of Washington County from **Jesse Wiggins of Effingham** County. Sale for 60 pounds sterling, 200 acres in Washington County "Butting and Bending on the Big Hoopey Creek on the South

Westward, being one half and the lower end of a tract of four hundred acres of land granted unto the said **Jesse Wiggins** by the Honourable George Mathews Esquire on the seventh day of February 1787. Witnesses: Thacker Vivian, J.P., Mary Vivian.

Attested 23 Mat 1894 [sic]

COMMENT:

Jesse Wiggins also held a 15<u>4?</u> acre grant adjoining Absalom Lott. See Image files for Tattnall grants.

Many of the Lott genealogies that are posted online say that they, too, came to Montgomery from Effingham.

Robert Braswell to **Cader Price**, both of Washington County, sale for 26 pounds sterling, 200 acres in Washington County on the North side of the Great Ohoopee River . . . "butted and bounded as follows: "Beginning at a bay and running along a line of marked trees North 50 degrees East 44 ch. 73 lks. To a stake thence running South 50 degrees East 44 ch 73 lks to a stake, thence South 50 degrees West to the Ohoopee, thence up the various courses of the same to the first station. ... agreeable to the original plat thereof." Witnesses John Fleetwood, Geneper [Juniper] **Hall**.

(pp. 14-15) Similar sales of land on Great Ohoopee were made by Braswell to Hardy Hargrove and Jacob Hargrave on 2 January 1793.

John Phillips of Montgomery County "in consideration of the love and true affection ... for my well beloved children," gives "to Abraham, my homestead plantation, together with all my furniture together with twenty head of Cattle. To my son Ephrim, one roan mauer [sic] together with four head of cattle. To my son William, twenty three head of cattle." Phillips X'd. Witnesses: Haney Yaster, Jesse Wiggins."

William Price (x) of Burke County to Solomon Wood of Jefferson, sale for \$75, 200 acres in Montgomery County on little Ohoopee Creek, surveyed for William Price "But through a mistake in the office the grant has come out in the name of **Thomas Price**, bearing date August 1, 1790." Witnesses: J. Raiford, J.P., Charlotte Minis?, her mark.

12 March 1798

Deed Book CPG:322-23

John Watts of Montgomery County to Archabald Culbraith of same, sale for \$171, 200 acres "being part of a tract of land containing four hundred and sixty acres, on which the said John Watts now lives, including a plantation. Beginning at the mouth of the Bluff Branch at the Ohoopee river, running with the said Bluff Branch to the second line, thence N 60 West to the tract corner, thence N 30 E to the Ohoopee river, thence with the said river to the first station. Witnesses: Lazerus Solomon (x), James Erighich [sic], Aron Low, J.P. Recorded 23 July 1802.

Comment:

This appears to be the tract that adjoins the 425-acre grant of Cader Price's associate Abner Davis. See Davis plat in image files for Tattnall grants.

Montgomery Co., Ga., 6 September 1798

Deed Book CPG:390-91

"I, **Hinche Warren** of the State of Georgia and County of Burke being aged but of perfect and sound in mind and memory do make and ordain this my last will and testament. Sons Carolus Warrren, daughter Mary Green ("I send her ..."), daughter Rachel Green, son Henche Warren ("I send him..."), son Josiah Warren, son Richard Warren. Most get slaves (several each). Richard gets the plantation where the testator now lives, in addition to slaves. Josiah and Richard are to be executors. Witnesses: John Cocke & Demsey Murphey. Hinche signed.

20 April 1801

John Johnson (x) of Bulloch County to James Johnson of Burke County, for 30 shillings, sale of 200 acres in Montgomery County, etc. Witnesses: Francis Pugh, **Jesse Wiggans** (x).

25 March 1796

Deed Book CPG: 405

Isaac Perry of Burke County to James Sartain of Montgomery, sale for \$40, 500 acres of land in Montgomery ... Witnesses: William Hall, Cadder Price (x).

COMMENT:

James Sartain's 1800–1802 grant lay between Arthur Lott and Nathan Lott.³ Sartain was not a land speculator. The land he bought above should have been in the immediate neighborhood of his grant, which means that he and Cader Price were also in the neighborhood of Arthur and Nathan Lott.

James Sartain of Montgomery to William Gary of Burke County, sale for \$40, 500 acres in Washington, now Montgomery, grant dated 28 November 1795. Witnesses: **William Hall, Cader Price** [doesn't say he x'd].

COMMENT:

As shown in various documents abstracted herein, Capt. William Hall and Ignatius Hall were neighbors of the Lotts and Watts on Old Saw Mill Creek. Both Halls were authorized to keep the ferry and operate a tavern.

Ignatius, in 1806, had a wife named Zilpha, one of only two other Zilphas I have been able to identify for Montgomery and Tattnall Counties (and both of the other are kin).⁴ **However, Zilpha Hall is named in only one known record, that 1806 document.**

⁴ "1 August 1806 - (Petition) John P. Blackmon says **Ignatious Hall and Zilpha Hall, his wife,** owe him \$1,000 in damages. On 1 June 1806 they publicly said, 'He was a liar and a recorded liar in the Clerk's office of Tattnall Co. and they could prove it'. They are required to appear at court th4 2nd Monday in October." See Sabrina J. Murray, abstractor, *Tattnall County, Georgia, Loose Papers, 1801–1845,* vol. 1 (Homerville, Ga.: Huxford Genealogical Society, 2005), 27.

Apparently, Ignatius left a widow of a different name. According to one Hall researcher: "An Ignatius Hall, b abt 1755, was a Revolutionary War soldier of the North Carolina line, according to his pension application which was filed 11-04-1830 in Tattnall Co Ga, which stated he was formerly of Halifax NC. He was probably the son of Ignatius and Mary. He may be the Ignatius Hall who was found in the 1790 Moore Co NC census. He showed up in Ga in Washington then Tattnall County where he lived in the early 1800's before moving to Thomas County Ga where he was in the 1830 census, and where he died in 1840. His wife was named Elizabeth, no further information about her. Their children were Bethany, Jordan, Thomas Lant, Mary, and Lucinda Hall." See Carol B.
