Dorothée Monet: French & African Freedwoman (30 October 1777—*aft*. 17 December 1821)

Research Notes

Dorothée Monet Family Summary:

Born:30 October 1777, Grand Coast plantation of Jean Baptiste Dupré, Natchitoches Post¹Daughter of:Marguerite (African) of Guinea; and Louis Monet (French Créole, 1753–1804)²

Relationships: (1) Jean Baptiste Balthasar (griffe), who later married Marie Rose Metoyer (French and African)

- (2) likely Jean Pierre Cloutier (French Créole)
- (3) *likely* **Pierre-Toussaint Metoyer** (French and African)

Died: after 17 December 1821

Child of Dorothée and Jean Baptiste Balthasar (griffe):

 J. B. CYRIAQUE MONET, b. c1795, Rivière aux Cannes; carpenter; married 28 November 1837, Isle Brevelle, Marie Marguerite LeComte, "major daughter of Magdeleine Le Comte," all free people of color. At marriage, they legitimized three children: Baptiste, born c1828; Marie Elina, born September 1830 (1835?), and Marie Lise?, born October 1836.³

Child of Dorothée and, likely, Jean Pierre Cloutier (French Créole):⁴

 MARIE HENRIETTE DOROTHÉE CLOUTIER, b. about December 1796,⁵ Rivière aux Cannes; married: (1) Pierre Metoyer Jr., free man of color, son of Pierre Metoyer (French) and Marie Thérèse Coincoin (Black Créole), 31 December 1817;⁶ (2) Émile Dupart, free man of color, son of Charles Dupart and Victoire Mulon, 14 November 1842.⁷

RESEARCH NOTES

1 MARCH 1778

Baptism of **Dorotea**, born 31 October 1777, natural daughter of **Margarita**, a slave of **Juan Bautista Dupres**. Godparents: Joseph Dupré and **Dorotea** Peraut.⁸

10 NOVEMBER 1781

Succession, Jean Baptiste Dupré, inventory itemizes "Negress Marguerite aged 35, and her mulatto daughter, Dorothée, aged 3.⁹

COMMENT:

- The 7 September 1769 marriage contract of Jean Baptiste Dupré to Marie Louise Marguerite LeComte includes a list of his enslaved people but does not include Dorothée's mother Marguerite.¹⁰ Apparently, he acquired Marguerite between 1769 and 1778.
- The 1781 will of **Dupré** gives freedom to **Jean Baptiste Balthasar**, a "griffe" aged 7, and Cécile, aged 9, "in consideration of the good services of their mother, an **Indian** of the _______ nation" [*sic*].¹¹ Balthasar would be the father of Dorothée's first child, born 1795 and baptized 1797. See that date below.
- That son, baptized as "Jean Baptiste" and inventoried in 1825 as "J. B. Suriaque, son of Dorothé," married in 1837 under the name "Cyriaque Monet ... son of Baltazar Monet and Dorothée Monet." (See below for both the 1825 and 1837 records.)

15 AUGUST 1785

Mme. Veuve B^{te} Dupré sells the following to **Louis Monet**:

- a *negresse Creolle* named Françoise aged 23, and her children
 - her son Remy aged 6
 - o a small mulatto named Marie Louise aged about 3 years
 - o a small *nègre* named Charles aged about 1 and ½ years

COMMENT:

This Françoise was the daughter of Marie Thérèse Coincoin, illegally sold as a child by her mistress to a trader who immediately resold her to Jean Baptiste Dupré.¹² As a free woman of color, Dorothée is found repeatedly in records of Françoise's free brothers surnamed Metoyer.

- a *negresse* named Thérèse, aged about 40 years and her children
 - o a small nègre named Athanaze, aged 7
 - o a small *negresse* named Nanette, aged 3 years
 - o a small negresse named Marie Josephe, 2 years

- a small mulâtresse named Dorothée, aged 7 years
- a young *negrillon* named Antoine, aged 15
- 3 arpents frontage of land, to the depth that it is able to carry.

The price for the slaves is 3500 piasters. The price for the land is 69 piasters. Total 3569 piasters. Widow Dupré made her mark. Louis Monet signed neatly. Witnesses: Paul Marcollai, Joseph Capuran. Pierre Rousseau, commandant.¹³

10 OCTOBER 1785

Marriage contract of **Louis Monnet**, major son of deceased Pierre Mathieu Monnet and deceased Babet [Elisabeth] Rachal, native of Natchitoches, with **Widow Baptiste Dupré**, daughter of deceased Jean Baptiste Lecompte and Marguerite LeRoy, native of Natchitoches. The inventory of slaves belonging to Monnet included: "one *negresse* named **Marguerite**, **native of Guinea**, aged 30, and her child, "**a small** *mulâtresse* named **Dorothé**, **7**, valued at 500 piasters." Land consisted of 4 arpents frontage at one league (about 3 miles) from the post, on the east side of the river, bordered above by Athanaze Poisot and below by the bride.¹⁴

22 FEBRUARY 1797

Baptism of **Jean Baptiste**, aged two years, **mulatto son of Dorothée**, **mulatress** slave of **Mr. Monet**, and a father unknown. Godparents: Louis Rachal, represented by Louis Monet, and Margueritte Leroi, Widow [J. B.] Lecompte, represented by Margueritte Lecompte [wife of Monet], her daughter.

Baptism of **Henriette**, aged two months, **quadroon daughter of Dorothé**, **mulatress** slave of Mr. Monet, and a father unknown. Godparents: Louis, a free mulatto, and Marie Louise, a free mulatress.¹⁵

COMMENT:

The presence at this baptism of the old Louis Rachal suggests that Dorothée is living at Lower Rivière aux Cannes, where her father and his uncle Louis Rachal were near neighbors.

1801

Louis Monet "agrees to the estimate that has been put upon a *mulatress* named **Dorothée**, aged about 22, which belonged to him, having acquired her from **Madame Marie Louise** before his marriage to said lady. Therefore Emanuel Derbanne has paid him \$800 for her freedom."¹⁶

COMMENT:

Third-party manumissions of this type are typically found, at Natchitoches, in cases in which the white father wanted to manumit an enslaved child he had fathered but did not want to publicly acknowledge.

I have found no evidence of a prior or subsequent relationship between Dorothée and Derbanne.¹⁷ Neither this Dorothée nor her children would ever use the Derbanne name.

20 MAY 1804

Baptism of Thérèse, aged 1 year, daughter of Thérèse, slave of Me. Veuve Jacques Fort. Godparents: Jean Baptiste, slave of Mr. Metoier and **Dorothée, a free mulatress**.¹⁸

COMMENT:

This record suggests that Dorothée, as a free woman, moved back to the Grand Coast where she had been born. This is the area in which Louis Monet lived at the time he fathered her.

"Mr. Metoier" was Pierre Metoyer, the French father (by Marie Thérèse Coincoin) of the multiracial Augustin, Louis, Pierre, and Toussaint Metoyer who are frequently referenced in this set of research notes for Dorothée.

1 JUNE 1806

Baptism of **Pierre Noel**, Negro born 24 December 1805, son of Margueritte, slave of **Marie Thérèse** [Coincoin], free Negro. Godparents: Athanase, free Negro, and **Dorothée**, free mulatto.¹⁹

COMMENT:

Again, Dorothée's actions of record place her in the neighborhood of her birth.

30 DECEMBER 1806

"Jean Baptiste Balthazar claims a tract of Land in the County of Natchitoches, containing 353.12 acres, superficial, on both sides of Red River, having the front Breadth & Depth as figured on the enclosed plat, which by Virtue of a Concession to him accorded by the Baron Carondélet dated the 18th May 1796 which Requette & plat are filed with this notice & having resided upon & cultivated the same agreeably to the Acts of Congress for ascertaining and adjusting the Titles & Claims to Lands in the Territory of Orleans & District of Louisiana. Decr. 30th 1806. For the claimant Jas F. Porter. Recd. 2nd March 1812 the Plat filed in this claim, Joseph Irwin."²⁰

COMMENT:

Porter, a justice of the peace who filed Balthazar's claim, was the third husband of Marie Louise Marguerite LeComte, widow of Dupré and Monet.

Note that Porter, like Cloutier in 1812 when he filed an affidavit for Balthazar, used no racial designation for Balthazar. However, the plat created by Sam Cook, Deputy Surveyor, on 9 February 1807 called him "John Bat^e Baltazar, a free *Mulatto.*" Both Porter (whose land lay adjacent to Balthazar according to the plat) and Cloutier used the term "mulatto" freely for other people of color. The will by which J. B. Balthasar was freed as a child called him a *griffe*— i.e., a person of Native-American and African-American parentage. The sister freed with him was not identified as a *griffe* or *Indien*, implying that her father was white.

4 JUNE 1810

Credit sale for the purpose of manumission. Widow Monet, wife of Porter, conveys **Henriette** to Toussaint Metoyer. \$640 on credit.²¹

COMMENT:

See the subsequent document of 1811 in which Widow Monet conveys Henriette to *her mother Dorothée,* not to Toussaint Metoyer who had assumed responsibility for buying her freedom.

2 NOVEMBER 1812

Marie Louise LeComte Porter (x) sells to the free *mulatresse* **Dorothée** (x) a young *mulatresse* named **Henriette**, aged about 16, for \$650 cash. It is the intention of both parties that Henriette is to be free. Witnesses: Comte *fils*, and Brun.²²

COMMENT:

Mme. Porter (Widow Monet) did not use the surname Monet for this Dorothée.

18 NOVEMBER 1811

"In the claim of **Jean Bte. Baltazar** for a Tract of Land in Red River in the County of Natchitoches, **Alexis Cloutier** being sworn deposeth and saith that the Tract of Land claimed has been inhabited and cultivated for more than twelve years preceding this date without interruption by the Said Baltazar. [Signed] Alexis Cloutier (x his mark), Sworn at Opelousas in Presence of the Board, 18th Novr. 1811."²³

11 AUGUST 1813

SUCC. BOOK 1:49-50

Marginal note: Succession of "Jean Bte., free mulatto." Text identifies him as **Jean Baptiste**, *homme de couleur libre*, who died in the month of May 1812. **Pierre Charuau**, justice of the peace in the parish of Natchitoches, district of Isle à Brevelle, acting under order of the parish judge, at the request of **Louis Metoyer**, *mulâtre libre*, executor of the will of deceased "Jean Baptiste *homme de couleur* and Marie Rose, his widow, has gone to the residence of the said Louis Metoyer at Isle à Brevelle, to make an inventory of the goods in the presence of Mr. Lavespère and Charles LeMoine. Goods are a typical assortment of items held by a yeoman farmer, along with one *négre Créole* named Toussaint, aged about 15 years (\$150), and a tract of land containing 6 arpents frontage on each bank of Red River, with the depth it is able to carry, bounded above by land of Mr. B^{mie} Rachal and below by Mr. Nicolas Boden (\$300). Items on this land were, after the death of the deceased, carried to the domicile of the said Louis Metoyer for estimation. Signed: P^{re} Charuau, Justice of the peace; Lavespère; Charles Lemoine (x); Louis Metoyer (x); Marie Rose (x).

Balthasar's will reads, in part: "I, Jean Baptiste, a free man of color, the son [torn] of an Indian woman" bequeath to "my wife Marie Rose Baptiste" 1/3 of my land on Red River containing 10 arpents frontage on each side, with ordinary depth, bounded on the upper by lands of Alexan[der] McAlpin and below by lands originally belonging to Louis Monet. "To my son Jean Baptiste," 1/3 part of my land. "To my daughter Marie Rose Baptiste," 1/3 part.

COMMENT:

Balthasar's land, adjoining McAlpin, lay in the Hidden Hill area of Rivière aux Cannes, below Cloutierville. McAlpin's plantation is today known as Little Eva.

21 AUGUST 1813

Marginal note: "Public sale of the goods of deceased **Jean Baptiste**, *man of color."* Same ethnic label in the document. Sale conducted by Charuau, at domicile of Louis Metoyer, in presence of Marie Rose "also a free *mulatress*, his widow." Purchasers: Mr. Louis Metoyer M.L., Mr. Guillaume Bernard, Augustin Metoyer with Mr. Baptiste Latier as surety, François Millon with Dominique Metoyer as surety, Mr. Jn. Pre. Mie. Dubois with Mr. **Etienne Rachal** as surety, Mr. Guillaume Bernard with Mr. Lambre *fils* as surety; Dominique Lange M.L. with Augustin Metoyer surety, François Metoyer M.L. with Augustin Metoyer surety, Augustin Metoyer with Baptiste Lattier surety, Mr. Pierre Nolasque with Charles Lemoin surety, Augustin Metoyer with Baptiste Lattier surety, Charles Lemoine with Jean Massippe surety, Mr. Porter with Augustin Metoyer surety, Joseph Jonca with Joseph Metoyer surety. Louis Metoyer bought the land. Signed: Lavespere, Comte fils, Anty, P^{re} Charuau, Justice of the peace. Approved by P. D. Cailleau Lafontaine, parish judge. \$1083.40 total. Land not sold.²⁴

8 JANUARY 1818

Marriage. **Pierre Metoyer** and **Henriette**. [Entry partially destroyed]. Groom: native of this post, free man of color, widower of Marie Perinne. Bride: native of this post, aged 18 years, natural daughter of **Dorotea**, also a free woman of color.²⁵

8 JANUARY 1818

ST. FRANÇOIS CHURCH

Baptism of unnamed child [Marie Ozitte], born 14 ____ 1816, legitimate daughter of Pier Metoyer and [blank; should be Henriette], all free people of color. Godparents: **Ciriac** and **Dorotée**, both colored.²⁶

COMMENT:

J. B. Cyriaque was the older brother of Henriette. The godmother who served with him would be his and Henriette's mother Dorothée. Note that the surname *Monet* is not being applied to her, although Cyriaque, at his marriage in the 1830s, identified his mother as "Dorothée Monet."

7 AUGUST 1820

CENSUS

[Census of Natchitoches Proper continued"—i.e., the Grand Coast, from Natchitoches down to Isle Brevelle]²⁷

COMMENT:

Neither Dorothée nor her son J. B. Cyriaque are heads-of-household on this census. The household data for Dorothée's daughter Henriette and husband Pierre Metoyer, fmc, do not have excess family members of the right age to be Dorothée or Cyriaque. Considering the number of instances in which Dorothée appears on record coupled with Toussaint as godparents in this era, it appears likely that she is the female listed in a "wife and mother" position in Toussant's household.

COMMENT:

The only discernible candidate for "Gones Con" is Augustin Metoyer's full-*nègre* half-brother Nicolas Coin Coin who used his mother's *dit* (*var.* Conne Quoin and numerous other phonetic spellings) as his surname. If so, then he is double-listed on this census—appearing again above Natchitoches as a male head-of-household named only as "Coincoin." Nicolas had a land claim adjacent to Augustin; the two executed a land swap, with Nicolas settling on the distant land in Township 10 above Natchitoches.²⁹

17 SEPTEMBER 1821

Baptism of Marie Aselyne, daughter of Catarina, free woman of color, and a father unknown. Godparents: **Toussaint Metoyer** and **Dorotea**, both free people of color.³⁰

Baptism of Marie Henriet, 4 months, daughter of Fany, slave of Louis Bmy. Rachal Jr. Godparents: **Tousain Metoyer** and **Doroté**, free people of color.³¹

30 NOVEMBER 1821

Baptism of an English Negro aged about 22, slave of Pier Metoyer. Godparents: **Tousain Metoyer** and **Dorothea**.³²

17 DECEMBER 1821

Baptism of Athanas, Guinea Negro aged 18 years, slave of **Louis Metoyer**. Godparents: Dupalier Vidol and **Dorothée.**³³

COMMENT:

Three Cane River women of color in this era were named Dorothée; all were associated with the Metoyers *de couleur*:

- Dorothée Monet, French-Indian, whose sister Thérèse married Louis Metoyer, fmc.
- **Dorothée "Monet,"** French-African, whose daughter married Louis Metoyer's brother Pierre.
- **Dorothée Boisdoré,** French-African, who married Joseph LaVigne, fmc, after she was purchased from the Derbannes and freed by Augustin Metoyer, fmc. At her marriage in 1814,

this Dorothée identified herself as Dorothée Boisdoré, aged 30 and daughter of Françoise.³⁴ This suggests that her purchase and manumission by Augustin may be due to a sister relationship with Augustin's wife Agnes whose black mother Françoise was a Derbanne slave. (Joseph LaVigne, Dorothée's husband was also a witness to the marriage of Augustin's daughter Marie Louise to Florentine Conant in 1815 or 1816.³⁵)

Lavigne's wife Dorothée continues to appear in church records without a surname:

- 8 June 1815, baptism of Antonio, son of Maria, slave of Louis Metoyer who gave liberty to the child. Godparents: Jose LaVigne and Dorotee, free mulattoes.³⁶
- 20 March 1820, baptism of Marcelite, daughter of Jeny, slave of Augustin Metoyer. Godparents: Joseph Lavigne and Dorothee, free people of color.³⁷
- 17-18 December 1821, baptism of three Guinea slaves of Augustin and François Metoyer. Godparents: Joseph Lavigne and Me. Dorothea.³⁸
- 6 July 1822, baptism of Joseph, son of Marie, slave of J. B. Lattier Sr. Godparents: Joseph Lavigne and Marie Dorathee, free.³⁹
- 10 August 1822, baptism of Athanase, English negro, 25, slave of Dominique Metoyer: Godparents: Jose Lavigne and Dorothee.⁴⁰
- 25 August 1825, baptism of Marie Lilette Sarpy, daughter of Jerome Sarpy and Maire Jeanne Metoyer. Godparents: Joseph Lavigne and Marie Dorothée.⁴¹
- 25 October 1825, baptism of daughter of Marie Perine, slave of J.B. Lemoine. Godparents: Henri Denis and "Olympie" [Dorothée] Boisdore.⁴²
- 27 May 1826, baptism of daughter of Marie Louise, slave of Florentin Conan. Godparents: Joseph and Marie Dorothee.⁴³

"Groom: major son of Baltazar Monet and of **Dorothée Monete.** Bride: major daughter of Magdeleine Le Comte. All are free people of color and residents of this parish of Natchitoches. Witnesses: Louis Morin (s); Charles Nerestan Roques (s); Jean Baptiste Metoyer *fils* Augustin (s). Priest: D'Haund.

"Ed. note: At the close of the original entry in Register 8, there appears the following, barely-legible list which seems to name children being legitimized: 'Marie Elina, born September 1830 (1835?) Godparents: Octave Deronce and Lise? Roques; Marie Lise?, born October 1836, Godparents: Louis Morin and Suzette Metoyer; Bte. (illegible) 9 Years."⁴⁵

COMMENT:

The pastor who recorded this marriage did not indicate whether spouses of the parents (Dorothée Monet, specifically) might be alive or deceased.
